Competitors and horses will be presented in a clean, tidy, and well-groomed manner. No inhumane treatment of horses shall be tolerated and if such practices are observed, a Rusty Gaits Executive Member reserves the right to eliminate you from competition and further probationary measures may be considered.

Ensure you fill out all entry cards with complete and accurate information prior to the start of the class. If you are entering multiple horses in one class, ensure your back numbers correspond to the correct horse.

Be safe, cheer each other on, assist with equipment changes and most importantly – Have fun!

Hold Harmless Waiver
